

## OFFICIAL RULES

### SCCU Presents VISA Debit Card Usage "Win" 2021 Promotion Terms and Conditions

1. **Sweepstakes Administration**

This sweepstakes is being administered and operated by SIERRA CENTRAL CREDIT UNION.

2. **How to Enter**

Account Holders who use their SCCU VISA "Debit" card for everyday transaction purchases at retailers or online during a month in 2021 will be entered into a drawing for a \$100 Gift Card to a Small Business of their choice that resided in their community. Each month is a new promotional month and transactions over 25 during a promotional month will enter you into the drawing. Each month is a new drawing period and transactions made during the prior month will not be counted in the current month. For each member account, for each card attached to the account, 25 or more transactions made from the 1<sup>st</sup> of the month to last day of the month will enter the account holder into the drawing for that month. No entry form required, 25 or more transactions made during a month will automatically be entered by account for the month.

3. **No Purchase Necessary**

If you desire to enter the drawing other than through using your SCCU VISA "Debit" card, print your name, address, telephone number, and the name of your branch location on a 3x5 card. Send the card to SIERRA CENTRAL CREDIT UNION VISA "Debit" Card Usage "Win" 2021 Promotion, Attn: Marketing, 1351 Harter Parkway, Yuba City, CA 95993. There is no limit to the number of entries you can send. Each entry must be handwritten, mailed separately, and cannot be mechanically reproduced. Entries must be postmarked by the last day of the promotional month to be eligible for that month. Any entry received after December 31, 2021 will not be eligible for a drawing. Entries received that do not comply will be disqualified. Entries will not be acknowledged or returned. Participants agree not to hold SIERRA CENTRAL CREDIT UNION or any of the sponsoring affiliates, their partners, their employees, their volunteer, and/or their affiliates responsible for lost, misdirected, incomplete, or illegible entries. The promotion period runs from 12:01 AM on January 1, 2021 until 11:59 PM PT on December 31, 2021.

4. **Sweepstakes Period**

The Sweepstakes period runs from 12:01 AM PT on January 1, 2021 until 11:59 PM PT on December 31, 2021.

5. **Eligibility**

To be eligible for the promotion you must be a legal resident of the United States (including Alaska and Hawaii) and at least 18 years of age on the date of entry. Void where prohibited by law. Any winning entry will be deemed to have been made by the primary individual named on the account. Prize winners will be notified by mail and must claim their prize. Any SCCU account individual may refuse the prize if drawn. Non-response to prize notification will be considered as refusal.

6. **Prizes**

From entries received during a promotional month, one (1) randomly selected winner will receive a \$100 Gift Card to a Small Business of their choice that resides in the community in which they live. The ticket drawing will occur on or about the 25<sup>th</sup> of each month for the previous promotional month. Winners will be notified by USPS mail and must claim their prize by returning a signed prize acknowledgement. Exact prize components are subject to change without notice. All decisions are final and binding. Neither SIERRA CENTRAL CREDIT UNION, nor their partners are responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify winner.

7. **Chance of Winning**

The number of promotion prizes is one (1) each month throughout 2021. The odds of winning a monthly prize depend on the number of entrants who have qualified for entry, of which one(1) winner will be drawn each month.

8. **General Conditions**

SIERRA CENTRAL CREDIT UNION will select all prize winners. Federal, state, and local tax liability and any other expenses are the sole responsibility of prize winners. Void where restricted and prohibited. Prizes are non-transferable, non-assignable and non-exchangeable.

9. **Consent to Publicity and Release**

By accepting a prize, winner's consent to the use of their name and likeness for publicity purposes without further compensation, unless prohibited by law. All entrants agree to release and hold harmless SIERRA CENTRAL CREDIT UNION and their partners, employees, agents, representatives, and affiliated companies from any and all claims of any kind arising directly or indirectly from the promotions, from any promotion prizes, or from any publicity about the promotion.
